Member O'Donnell introduced Mark Stanley, Executive Officer of the San Gabriel and Lower Los Angeles Rivers and Mountains Conservancy. Mr. Stanley gave a PowerPoint presentation on the programs of the Conservancy. He said the RMC is the only conservancy in the State of California located in an urbanized area. He described sustainability and balance as key concerns of the Conservancy and gave a brief background on the RMC.

Mr. Stanley said that the Conservancy has awarded \$64.5 million in grants for projects in the RMC area. He identified the mountains and foothills, urban parks, and rivers and wetlands as the three areas of concentration. He identified several current projects, including the San Gabriel River Discovery Center and Paseo del Rio.

It was the consensus of the Board to receive and file the report.

There was no report from the Conservancy Committee.

Jerry Wood presented a report from the I-710 EIR/EIS Project Committee. He said the draft EIR will probably be delayed until March. He said early action projects are underway,

including the sound walls and utilities studies. He said the ITS study is underway and is getting interesting results.

Jerry Wood presented a report from the SR-91/I-605/I-405 Corridor Cities Committee. He said the Committee is scheduled to meet on the 15<sup>th</sup> of the month. He said the initial traffic modeling for the feasibility study has been completed and cities are starting to address their versions of early action projects.

It was the consensus of the Board to receive and file the two freeway corridor reports.

The Executive Director presented a report from the Committee on Homelessness. He said the contract with the County had been completed and that staff had met with County staff yesterday to discuss the RFP process. It was the consensus of the Board to receive and file the report.

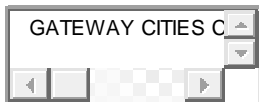

**Status Report from Lobbyist - Edington,

**Monthly Report by Jim Dykstra to Gateway Cities COG**  
**December 28, 2011**

I and the firm Edington, Peel & Associates continue to provide a range of services in support of the Gateway Cities Council of Governments. These include participation in a number of meetings, telephonic, email and fax exchanges and other communications.

I continued to closely coordinate with Gateway Cities COG staff regarding efforts on behalf of the Gateway Cities COG's priorities and interests in the first session of the 112<sup>th</sup> Congress. I have had telephonic and electronic exchanges regarding possible funding opportunities and legislation of interest. I also continued to work with the staff of the I-5 Joint Powers Authority on the I-5 widening initiative, the COG's number one priority.

I have kept the Gateway Cities COG informed of continuing developments regarding of the Transportation Reauthorization Act. As I have reported, both Rep. John Mica (R-FL), chairman of the House Transportation and Infrastructure (T&I) Committee, and Sen. Barbara Boxer, chair of the Senate Environment and Public Works (EPW) Committee, have indicated they hope to secure passage of the legislation, and the Administration has said that is its goal as well. Movement on the legislation has increased, but passage is unlikely until sometime in early spring. Funding of a bill remains the most difficult and contentious issue, and the two committees disagree on the length of the bill, with the Senate favoring two years and the House six. The Senate EPW Committee marked up its version of the measure on November 9. The House T&I Committee on November 17 unveiled its version of the bill, which would use revenue made by expanding domestic energy production to pay for infrastructure projects, which Democrats in both chambers oppose.

I participate on Gateway Cities' behalf in conference calls and email exchanges with the Coalition for America's Gateways and Trade Corridors (CAGTC) and provide Gateway Cities with information on CAGTC activities in Washington, DC. I suggested Gateway Cities provide an article on its initiatives for the CAGTC newsletter, something that is expected to take place in coming months. I also alerted Gateway Cities officials to concerns expressed by members of the Senate Commerce Committee regarding freight legislation endorsed by CAGTC.

As I have reported, both the Senate and House are not including any earmarks in the FY12 appropriations process. Despite that, Rep. Lucille Roybal-Allard accepted requests. I am in regular touch with her office on behalf of Gateway Cities, as I am with the office of T&I Committee member Rep. Grace Napolitano.

I have continued discussions and email exchanges with staff of Members of Congress representing Gateway Cities members, as well as other key congressional staff, regarding the COG's legislative priorities.

As part of my responsibilities, I closely monitor legislation, as well as seminars, hearings, meetings and publications of key interest to legislators and senior executive branch officials for articles and information of possible interest and importance to member cities of the Gateway Cities COG. I attend Senate and House committee hearings, follow Senate and House floor proceedings, and track legislative initiatives pertinent to Gateway Cities COG interests and priorities.

# **Metro Green Line to LAX – Project Overview by MTA Staff**

### **Background**

Metro is examining ways to connect the growing Metro Rail system to Los Angeles International Airport (LAX). The focus of this study is a four square mile area bounded by La Cienega Blvd. on the east, Manchester Ave. to the north, Imperial Highway to the south and the LAX airport terminals on the west. In the initial phase, a broad range of alternatives are under consideration for making the connection between the regional rail system and LAX, including various combinations of several modes, such as Light Rail Transit (LRT), Automated People Mover (APM) and Bus Rapid Transit (BRT).

Metro wants to hear about your vision for improving transit service to LAX, including how a connection to LAX might:

- Reduce traffic congestion and improve transportation options to and from the airport
- Best serve airport users and local employees
- Provide travelers with the level of transportation they expect when visiting a world-class city

Measure R, the half-cent sales tax increase approved in 2008, provides \$200 million in funding for the project.

### January 6, 2012 AQMD Board Meeting

The AQMD Board will be meeting on **January 6, 2012 at 9:00 am** at the AQMD headquarters in Diamond Bar. Items of interest include:

- **Funding and release of Program Announcement to Replace CNG Fuel Tanks on School Buses:** AQMD will be releasing a program announcement to accept applications from school districts to replace on-board CNG school bus tanks. The California Highway Patrol requires that these engines be replaced every 15 years. In addition, if the Board approves this item, school districts that have experienced damage to tanks on buses, regardless of the age, will be eligible to apply for replacement funds. In addition, the Torrance Unified School District will be awarded \$140,000 to replace faulty engines on 7 of its buses.

**Surplus Off-Road Opt-In for NOx (SOON) Projects:** AQMD has released PA #2012-04, seeking proposals to provide financial incentives to assist in the purchase of low-emission heavy-duty engine technologies to achieve near-term nitrogen oxides (NOx) emission reductions from in-use off-road equipment. Applications are due by 1:00 p.m. on **Tuesday, May 8, 2012**. More details can be found at: <http://www.aqmd.gov/rfp/index.html>.

**Zero-and-near Zero Emission Locomotive Technologies:** AQMD has released Request for Information (RFI) #2012-01 to obtain information from qualified entities to identify viable zero- and near-zero emission locomotive technologies that could be fully developed,

demonstrated and commercialized for freight and passenger transportation in the South Coast Air Basin (Basin). The information provided in response to this RFI will be used to evaluate technology options and assess the requirements for zero- and near-zero emission locomotives with the potential for future funding of such. ### **Recap of December 2, 2011 Board Meeting**

The Board met on December 2 at the AQMD building in Diamond Bar. Items of interest include:

**1. Released RFP for Zero Emission Goods Movement Demonstration Project (RFP #P2012-15):** Issued a RFP to solicit proposals for development and demonstration of a zero emissions goods movement system using linear motor technology. This is a follow up to a November Board item, which recommended a linear synchronous motor demonstration project with General Atomics. Staff withdrew a request for this project and now recommends an open solicitation where any interested party can submit a proposal.

The proposed project will be Phase 1 of a multi phase project. The first phase will include the development and demonstration to move at least a fully loaded 40-ft cargo container with zero stack emissions along existing railroad infrastructure. Matching funds by the contractor will be required – can be direct cash and/or in-kind contribution. Proposals are due to AQMD by **February 3, 2012.**

Higher consideration will be given to proposals containing the following items:

- Identify a business concept for the proposed system, including identifying revenue sources and projected operating and maintenance costs
- Describe approach to commercialize the technology upon success, including a second phase in a more representative port operations environment involving multiple vehicles with double stacked containers and switching operation
- Specific plan to obtain Federal Railroad Administration (FRA) certification
- Identification of other uses for the technology, such as heavy duty truck applications

**2. Approved Funding for Diesel Freight Locomotive Projects (Prop 1B Goods Movement Emission Reduction Program):** Approved funding for the repowering of six circa 1965 diesel Tier 0 locomotives with six new 2012 Tier 3+ engines in the amount of \$4.5 million dollars. BNSF will use these funds to repower 6 locomotives at use in Hobart Rail Yard in the city of Commerce. The contract life of these locomotives is 15 years and will result in emission reductions of 38.8 tons of PM and 466.3 tons of NOx from each locomotive over the 15 years project life.

**3. Approved funding for Multiple Air Toxics Exposure Study (MATES) Study:** Approved \$1.35 million in funding to conduct MATES IV study in the basin. The study will focus on the measurement of ultrafine particles in addition to toxic air contaminants. In addition, AQMD staff will prioritize exposure to ultrafine particles and diesel particulate matters near sources such as airports, freeways, rail yards, busy intersections, and warehouse operations. The study will begin in June 2012 at ten fixed sites to assess trends. The ten sites, which are the same locations as in previous studies, include Anaheim, Burbank, Compton, Inland Valley, an Bernardino (Fontana), Huntington Park, North Long Beach, Central Los Angeles, Pico Rivera, Rubidoux and West Long Beach.

#### **Other Past Events**

**Intermodal Container Transfer Facility (ICTF) Joint Powers Authority (JPA) Governing Board Meeting:** The JPA Board met on November 29, 2011 to discuss the status of the EIR for Union Pacific's proposed ICTF Modernization and Expansion Project. The JPA staff stated that they hoped to release the draft EIR to the public in late February 2012. In addition, the AQMD and the JPA have mutually agreed to dissolve Aim's contract for the preparation of the draft EIR. However, AQMD will continue to provide public comments on the project in its role as a regulatory agency. The JPA also approved a 3 year contract amendment with Environ International Corporation to complete the preparation of the draft and final EIR for the ICTF in the amount of \$1.2 million. **Southern California International Gateway (SCIG) Draft EIR Meetings:** Two public meetings on the Draft Environmental Impact Report (DEIR) for the proposed BNSF rail yard were held in Long Beach and Wilmington in November. Hundreds of residents, employees, labor members, environmental/environmental justice groups, and business / trade associations gave public testimony. The public comment/review period originally was scheduled from September 23 to December 22, 2011. **The public comment/review period has been extended to February 1, 2012.**
